## Consent Letter

Dear Valued Customer,

### Request for Consent to use Your Personal Data for Specific Purpose(s)

Our “CMB Wing Lung Bank Limited Notice to Customers relating to the Personal Data (Privacy) Ordinance” (“updated Notice”) contains important information about how CMB Wing Lung Bank Limited (“the Bank”) and its subsidiaries (collectively referred to as “the Group”) may use your personal data and to whom your personal data may be transferred.

- Commitments undertaken by the Group with local or foreign bodies or authorities, whether legal, regulatory, government, tax, law enforcement, self-regulatory, industry or others; and
- Obligations or arrangements relating to compliance with sanctions, or prevention or detection of money laundering, terrorist financing or other unlawful activities.
- Our updated Notice shows in full the above purposes that have been added.

### Your consent

The Group requests that you sign and return the Reply Slip at the end of this letter to consent to use your personal data for the specific purposes.

### Effect of not providing consent

As the specific purposes relate to the core purpose of providing services to you, if you do not give consent, the Group may be prevented from providing you with services. While the Group will not use your personal data for the specific purposes without your consent, the Group is allowed to continue using your personal data for the existing purposes as of the date of this letter.
